

# SOTI MOBICONTROL AND THE GDPR

The General Data Protection Regulation (GDPR) has prompted businesses around the world to improve the security and processing of personal data for EU residents. In addition to hiring/appointing key personnel, organizations must audit their current data security systems and identify any vulnerabilities. One key area of vulnerability is the storage and use of personal data on mobile devices. SOTI MobiControl is an industry leading EMM solution for the security and management of mobile devices, apps and content. It helps organizations reduce the risk of personal data breaches and simplifies GDPR compliance.

## What is the GDPR?

The GDPR is a European Union (EU) data privacy regulation that gives EU residents control of their personal data and protects their right to privacy. It is applicable to all organizations operating within the EU, including companies outside of the EU that deal with EU residents. The GDPR mandates that any personal data collected and used by a company must be consented to by the data subject, it must be controlled/protected, and it must be removed when requested. Failure to comply with GDPR regulations can result in fines of up to €20 million or 4% of annual global revenue, whichever is greater.

## Mobile Technology and the GDPR

Business mobility creates challenges for GDPR compliance. Mobile devices operate outside of the company's network allowing employees to access corporate data anytime and from anywhere. This makes them vulnerable to many threats such as malicious networks, lost/stolen devices, phishing websites, malware and accidental sharing of personal data. The GDPR requires that businesses demonstrate they have built data privacy into the design of their business mobility by design. An EMM solution is one of the key components for securing personal data in mobile devices and apps, making it easier to meet the requirements of the GDPR.

	<p><input checked="" type="checkbox"/> <b>ENFORCE SEPARATION OF WORK AND PERSONAL DATA</b></p> <p>Prevent accidental sharing of personal data in business apps and email accounts to personal apps or email accounts.</p>

	<p><input checked="" type="checkbox"/> <b>LOCK THE DEVICE, OR WIPE DATA/DEVICE</b></p> <p>Protect personal data on lost or stolen devices from being accessed by unauthorized parties.</p>
<p><b>BREACH NOTIFICATION</b></p> <p>Accelerate investigation and detection of data breaches to comply with the 72-hour notice period.</p>	<p><input checked="" type="checkbox"/> <b>AUDIT LOGGING</b></p> <p>Review device activities, policies, and administrative actions to assist in investigation/detection of data breaches.</p>
